AMONG OTHER RESEARCH ENDEAVORS, WE INITIATED COLLABORATION WITHIN THE BORDERLANDS LINKAGES INITIATIVE THAT FOCUSED ON PREVIOUSLY UNEXPLORED HABITAT IN THE STATE TO INITIATE THE FIRST STATE-WIDE JAGUAR MONITORING EFFORT IN SONORA. OUR FIELD TEAM CONDUCTED BIENNIAL ANURAN FROG MONITORING (LITHOBATES SPP.), AS WELL AS SEASONAL REPEAT PHOTOGRAPHY FOR LONG-TERM VEGETATION MONITORING, AND VISITING MEXICAN RESEARCHERS PERFORMED VEGETATION STUDIES WITH SATELLITE IMAGES TO ASSESS THE DEVELOPMENT AND RECOVERY OF NATIVE VEGETATION AFTER CATTLE REMOVAL.
