WE HELD OUR ANNUAL COMMUNITY-WIDE CELEBRATION AND PHOTO EXHIBIT TO HONOR THE VIVIENDO CON FELINOS RANCHERS IN OCTOBER 2022, SUSPENDED IN PREVIOUS YEARS DUE TO THE COVID-19 PANDEMIC. WE ALSO RESUMED OUR PLANNED MEETINGS AND RESTORATION WORKSHOPS WITH THE RANCHERS TO WORK ON CONSERVATION-ORIENTED SOLUTIONS TO HELP MAINTAIN THEIR LIVELIHOODS.
